



Participant Release and Waiver of Liability

I, the undersigned, am voluntarily participating with Journey to Enlightenment Tours and acknowledge and agree to the following conditions:

1. Limitation of Liability. As with all travel, there is always an element of risk present, and I understand and assume responsibility for any risks associated with any activity sponsored by Journey to Enlightenment Tours. I waive and release Journey to Enlightenment Tours, its owners, agents, employees, representatives and independent contractors, from any and all liability for my death, disability, personal injury, property theft, property damage or any actions of any kind which may be occasioned by any cause whatsoever in relation to my participation in any event sponsored by Journey to Enlightenment Tours. I further agree to indemnify and hold harmless Journey to Enlightenment Tours, its owners, agents, employees, representatives and independent contractors from any and all liabilities or claims made by other individuals or entities as a result of my actions, behavior or inactions during the trip. Journey to Enlightenment Tours, its owners, agents, employees, representatives and independent contractors assume no responsibility whatsoever in connection with the operation, safety, condition, service or failure to adhere to a published schedule of any aircraft, motor vehicle, boat, other conveyance, hotel, inn, winery, place of business or restaurant, etc. which may be used for services to Journey to Enlightenment Tours trip participants.

2. Trip Changes. Journey to Enlightenment Tours reserves the right, either prior to or after departure, in its good faith discretion, to change or reprice any tour as necessary. While we try to keep changes to a minimum, unforeseen circumstances (for example weather, strikes, acts of God, dangers, etc.) can happen. Changes can include, but are not limited to, the right of Journey to Enlightenment Tours to alter or omit any point of the itinerary, to substitute hotels, restaurants, activities, leaders, or to change any means of transportation without notice and without allowance for a refund, with the liability for increased costs – if any – to be borne by trip members.

3. "General Information". I have read and understood the "General Information" page of the website, stating what is included and not included, insurance recommendations, your responsibilities, reservations and deposits, cancellations and refunds, and trip changes.

4. Photographic Record. Any photographs, films or videos taken of me while participating in a Journey to Enlightenment Tours trip may be freely used for promotional and commercial use.
